LAW ENFORCEMENT AGAINST PROHIBITION

Christine Rogers spent many years in law enforcement, both on the street and in penal institutions. After years of embracing the “War on Drugs” she came to a conclusion. The war on drugs is an epic failure. In 27 years of law enforcement, nothing has changed for the good.

Two years ago she found LEAP, Law Enforcement Against Prohibition, and today she passionately spreads its message.

LEAP was formed in 2002 by five police officers. Today, the group is over 100,000 strong, made up of current and former members of law enforcement and criminal justice communities.

LEAP envisions a world in which drug policies work for the benefit of society and keep our communities safer. A system of legalization and regulation will end the violence, better protect human rights, safeguard our children, reduce crime and disease, treat drug abusers as patients, reduce addiction, use tax dollars more efficiently, and restore the public's respect and trust in law enforcement.

Ms. Rogers cited a number of compelling statistics, including the fact that while the United States makes up about 5% of the world population, we house over 25% of the world's prisoners. In fact, the United States federal prison population has increased over 800% if the past 40 years, largely related to individuals imprisoned for drug offenses.

LEAP's goals are: (1) To educate the public, the media and policy makers about the failure of current drug policy by presenting a true picture of the history, causes and effects of drug use and the elevated crime rates more properly related to drug prohibition than to drug pharmacology and (2) To restore the public's respect for police, which has been greatly diminished by law enforcement's involvement in imposing drug prohibition.

LEAP's main strategy for accomplishing these goals is to create a constantly growing speakers bureau staffed with knowledgeable and articulate current and former drug-warriors who describe the impact of current drug policies on: police/community relations; the safety of law enforcement officers and suspects; police corruption and misconduct; and the excessive financial and human costs associated with current drug policies.

March 7 – In 1965, a march by civil rights demonstrators was broken up in Selma, Ala., by state troopers and a sheriff's posse.

CHRISTINE ROGERS

After graduating from the Worcester Police Academy and the Massachusetts Department of Corrections Academy, Christine worked for nearly two decades as a Police Officer and Corrections Officer included being a rape investigator, a DARE officer and an undercover narcotics officer. During the 6 years she worked inside prisons she was on the extraction team regularly and supervised a work crew of 6. She was also elected a Constable in the Town of Hudson for two terms.

At the beginning of her career she was an enthusiastic supporter of the War on Drugs, but hard experience taught her both that it was futile, and that the wrong people were being penalized. She was tasked with guarding young girls who gang leaders would have hold their drugs and if caught get slammed with a mandatory minimum 10 year sentence while those men remained on the street, finding new girls to exploit.

She also had friends who were addicted to drugs and realized that they needed help, not prison. If resources were used for treatment and education instead of punishment, people in bad situations would have the space to turn things around and to lead productive lives. She saw first-hand how the present approach destroys that hope.

She is a firm believer in educating people, especially children, about the dangers of all drugs and that the prohibitionist approach, contrary to its stated purpose, actually hurts our ability to keep them away from our children.

Christine believes quite simply that people need help and should get it.



GETTING TO KNOW OUR ROTARIANS

Frank Newell was a plumbing, heating and air conditioning contractor in Aurora, Ontario when in September 1984 a client asked him to join Rotary. He enjoyed what the club was doing in the community and respected the values of Rotary.

Over the year he was a director in all Avenues of Service. In that same year he was asked to be a member of District 7070 Foundation Ambassadorial Scholarship Committee and then became very involved in the District Foundation and Rotary International.

Frank was asked by RI to be a "Site Visitor" for a proposed project financed by Rotary Clubs in The Netherlands and Germany. The project was located in Northern Ghana to install wells in the area around Tamale and Bolgatanga, tribal areas where only service water was available and the guinea worm disease is prevalent. Frank was asked by District 7070 to verify a project in Jakarta, Indonesia that was to install public washrooms in schools and communities in and around the city. He volunteered for a "Sweat Equity" project to help build a school in Siem Reap, Cambodia. Frank was a "Rotary Volunteer" to a project supplying potable water to a favela of 900 people in Ica Sur, Peru. He also volunteered to be a "Rotary Volunteer" building 28 homes with running water and septic systems in Jabaotoa Northern Brazil.

Frank helped with a limb project in Lima, Peru supplying artificial legs and the "Jaipur Foot" from India to amputees in Recife, Brazil. The last project he volunteered for was to help with schools in a village at the base of Kilimanjaro in Tanzania. Each of the trips allowed him to travel the country and enjoy the people, customs and food there.

THE HISTORY OF WOMEN IN ROTARY

The 1989 Council on Legislation vote to admit women into Rotary clubs worldwide remains a watershed moment in the history of Rotary.

"My fellow delegates, I would like to remind you that the world of 1989 is very different to the world of 1905. I sincerely believe that Rotary has to adapt itself to a changing world," said Frank J. Devlyn, who would go on to become RI president in 2000-01.

The vote followed the decades-long efforts of men and women from all over the Rotary world to allow for the admission of women into Rotary clubs, and several close votes at previous Council meetings.

The response to the decision was overwhelming: By June 1990, the number of female Rotarians had skyrocketed to over 20,000. By 2010, the number of women was approaching 200,000
